Dear All,

Bishop Mar Jacob Angadiath; is he the right Bishop we deserve?

We like to bring some facts about the Syro Malabar Chicago diocese and bishop Angadiath .

1. We all worked hard to get Chicago diocese, for our future generation (Our parents, kids and grandkids).
2. To get a better spiritual leadership and a strong community binding.
3. To sustain our true catholic virtues and practices.
4. To promote our native language and tradition.

17. Fr. (Mr) Sassery was caught by parishioners for sexual scandal and took him to his bishop house. Later Mar. Agadiyath brought him to serve our kids and put him in charge for the youths. He then repeatedly proclaim against Crucifix and later on left priesthood with his own cousins wife after engaging too many women. Finally we were able to send him away with many interventions.
18. Fr. Joji who was brought to us after receiving remuneration from his family. He later professes against crucifix many times and destroyed 16 families in Dallas and engages with 15 wives and one minor including one abortion. We were able to send him away with our frequent intervention.
19. Fr. Jacob Christy who has been in the USA for only 7-8 years is making \$20000 yearly salary build his home back in India for more than 1 crore rupees. He also decorated the house interior spending 15-20 Lakhs, Indian Rupee. He also builds his brother home and crying among laity for building his sister a home.
20. Fr. Kaduppan brought to USA after rejected from Palai diocese by Bishop Angadiath. He Steal \$600K from us and bought rubber estate and other real estate in Kerala who now serve as a priest in a remote village with his doctorate degree and law degree .we were able to send him away with our proper and timely intervention .
21. **Fr. Sebastian Vethanath Bishops very first cousin** brought him to USA as an Auxiliary bishop candidate. First year he was not seen to the public, but **protected in the Bishop house by his uncle-bishop**. After 2 year Mar Angadiath try hard to make him Bishop by hiding the fact that he is first cousin (against Cannon law). We were able to defect him with our proper intervention. Mar Agadiyath tried 2nd and 3rd times to make him Auxiliary. We have really witnessed a true thief and police play in the Bishop House between Bishop and his cousin Fr. Sebastian Vethanam. We were able to defect him with our proper intervention. A thorough

investigation and proactive restitution of Fr. Sebastian Vethanam is required against the wide spread talk among the faithful about his sexual allegation from New Jersey and spreading to other parts of USA now.

22. The appointment of Rev Fr. Sebastian Vethanath as the diocesan chancellor is against the norms of Catholic Church and as such the Bishop Mar Jacob Angadiath needs to take immediate action to remove him from that position. By keeping his relatives and benefactors, the Bishop himself involved and promoting a bad message to the faithful and clergy. 23. Later he bought Fr. Augsutine Palackaparampil , Fr. George Madathiparambil (retired) and Fr. Narikulam as the new bishop nominee; however the Godly intervention defect them all.
24. Bishops Angadiath's decision to install Fr. Augsutine Palackaparampil as the new Vicar of Chicago Syro-Malabar cathedral is an unholy decision. Rev. Fr. Augustin Palakkaparambil lost his merit as the VG of the diocese as of his public criticizing speech against the American Latin rite in a meeting and thus he lost the credibility and trusted Vicar of the cathedral.
25. A thorough enquiry and disciplinary action is required to this effect to avoid a much bigger damage to the church due to money laundering and looting from the church by the priests.
26. Bishop Mar Jacob Angadiath visited and apologized to the so-called sex-abuse victim for pardoning his priest's mischievous behaviors. Then he selected one of the victim's family members as the Sacristan| trusty of the church. Is he a bishop or a criminal?
27. Bishop Angadiath secretly worked with the Sacristans in Garland, Texas and removed the Crucifix from the main hall to spare for a party hall to serve liquor during party events. While the KCBC rally against liquor sale in Kerala, a brother Bishop in the USA is going against the flow is unacceptable. Why Bishop Mar Jacob Angadiath decided to remove the Crucifix that has been there from the beginning of the Garland church. Please remember that many Bishops and priest offered many mass for many years in that hall. This proves that he serves the worldly god.
28. A day before the consecration of a new church in Austin Texas, he worked behind the scene to install a gigantic Mar-Thomas cross and VEIL in the altar of the church at midnight; however the faithful rally against his move and stop the installation of Mar-Thoma cross and VEIL. The same crooked approach he employed in another two churches ex. Washington and Baltimore in the USA.
